ORGANIZATIONAL OVERVIEW

GENESIS OF THE ORGANIZATION:

Agragati Seba Sangstha (ASS) is a nongovernment; non profitable, nonpolitical and voluntary development organization was established in 2003. It was then registered with Department of Social Service under Ministry of Social welfare. A group of social activist found that underprivileged section of the people like hardcore poor and poor people, women, girls, marginal farmer and business people are living under poverty line due to lack awareness, knowledge, skill and financial capital. They had daily food crisis, poor health and sanitation, substandard housing, inadequate education and medical treatment. They were also less social dignity. They were not organized and lack of leadership. Government services were very less and sometimes it was not reached at all to the real people. In this context ASS was established. Later on, the organization was registered with Department of social Service under Ministry of Social welfare, Bangladesh. Later on it also registered with NGO Affairs Bureau of Bangladesh and Microcredit Regulatory Authority (MRA), Bangladesh.

ONGOING PROGRAM/PROJECT ACTIVITIES

1. Microfinance Program

Agragoti seba sangstha (ASS) started microfinance program since 2003 at the aim to uplift economic growth of the beneficiaries. The program has 4 components such as Samity/Institution building, micro credit, savings mobilization, and deposit scheme.

A. Samity/Institution Building:

Agragati Seba Songstha (ASS) started to organize the poor, distressed and underprivileged people of the rural areas. The rural people, women in particular, are socially degraded, economically dependent, professionally unemployed and personally underprivileged. These poor and distressed people have little access to social, political and family decision-making process Socio-economic condition of the Peoples with Disabilities is worse than other people. Their basic rights are violated and they live a subhuman life. They were unable to fight against their misfortunes individually because they are ignorant, unaware and dependent. ASS intends to develop institutions of the poor and make them conscious in order to enable them to identify, analyze and understand the reasons for their distress and dependency as well as find out possible solutions.

B. Savings Mobilization

ASS always believes that people has the capacity to make any positive change. ASS provides motivational program for its beneficiaries to build capital for future. The weekly group meeting helps them to be remarkable savers. Status of savings mobilization is shown table below:

Investment is a compulsory element of the programs, savings are entered in the passbooks of each member and interest accrues over their savings at the usual bank rates. The members take their borrowings on one hand and side by side deposit their personal savings on the other hand. Savings deposits vary from a minimum of Taka 20(twenty) per week to any given maximum amount. Thus the members become accustomed with investing for their future through this program. The members pay the installments and deposit the savings to the field organizers of the organization on a weekly basis. Thus the members effectively get banking facilities brought to their homes. Agragati Seba Sangstha (ASS) is giving logical rate of interest to the borrower on their saving.

C. Deposit Scheme

The name of deposit scheme is known as Agragati Deposit Scheme (APS). The members of the samity have special option to deposit monthly any amount and it will be continued each month once. The amount generally 200 to 1000. Interest will be given yearly end of financial year it is June. The interest is given according to the rules of the scheme.

2. Rural Housing project

Most of the ultra poor/hardcore female headed women are living in hut which is substandard and not health friendly as well as insecure. They have no financial ability to build a standard house for health, security as well as social dignity. Other hand, some have been affected and/or have lost their houses because of disaster like seasonal storms, river erosion they could not build housing due to lack of financial capital.

To address the problem, Bangladesh Government create a fund in 2003 namely "Grihayan Tohobil" and handover it to Bangladesh Bank. In this process Bangladesh Bank selected different NGO's all around the country through a standard selection process. ASS has selected for the program execution in Narsingdi district Belabo upazila and Raipura Upazila and initiated the program in the year 2003, with a view to provide standard housing facilities among the rural poor and rehabilitate the families who have been affected and/or have lost their houses because of disaster like seasonal storms, river erosion etc.

Selected women are being provided with 70000 to 250000 taka loan for house making and assists in building house through cooperating in all necessary arrangements. The house loan borrowers repay the loan by installment.

Objectives of Rural Housing:

- A. To provide moderate housing facilities among the rural poor to rehabilitate the families who have been affected disaster like seasonal storms, river erosion etc.
- B. Protect the public health and aware them about diarrhea and cold diseases and so on
 - ➤ Beneficiaries: Hardcore women/persons with disabilities family
 - Donor/Partner: Bangladesh Bank [Grehayan tahabil]
 - Working area: Belab upazila and Raipura upazila in Narsingdi district
 - Project duration: 2021 to till
 - Activities:
 - Selection of beneficiaries women in according with set criteria
 - Provide loan 70000 to 250000 taka to per person/house
 - Assist them in arranging house materials and establish houses
 - Provide counseling support for using house environment spoonful
 - Collect installment of house loan installment from house recipients
 - Report to Grihayan Tohabil as directed

So far Agragati Seba Songstha (ASS) has distributed 200 houses among 200 families.

3. Support to Pregnant women for normal growth and safe delivery

Bangladesh is recently entered in developable country but steal now 22% people live in under poverty and also 18% are hardcore people among them. Near about 50% people are women of total population. The poor people especially women could not meet their daily food requirements. So they are suffering from malnutrition.

Other hand pregnant poor women could not take daily require nutritious food and they are not enough aware pregnant & delivery period management and responsibilities. So they gave under weight children, immature baby and face different type of complication. Sometime die pregnant mother and children.

So Government of Bangladesh implementing pregnant mother allowance program through department of women affairs under ministry of women and children affairs ministry.

Agragati Seba Songstha (ASS) is implementing this program at Belabo and Shibpur upazila under Narsingdi district with the fund and supervision of Department of women affairs from June 2015.

Following objectives are given below;

- To raise awareness on primary health of pregnant mother
- To reduce child and maternal mortality
- Increase awareness level on pregnancy of pregnant mother
- Assist them at the period of pregnancy, delivery and post delivery to get service from local government service providers
- Help them to get family planning and EPI
- Awareness rising on demerits of dowry, violence of women & children, divorce, polygamy, child marriage and insist them not to do this.
- · Ensure birth registration and marriage registration

- Provide training to pregnant mother following govt. directorate given modules
- Stopping child marriage
- Link pregnant mother to different service provider organization
- · Awareness raising on breast feeding

ASS distributed monthly allowance and trained to 986 pregnant mothers which 522 at Shibpur upazila and 464 at Belabo upazila and raised up knowledge on different health issues.

4. Establish education institution for rural children

Mainstream education is one of the major focused areas of the organization. ASS is implementing different educational activities in its operational areas.

Jangua Noakandi is a village of Narayanpur Union under Narsingdi district, where educational facilities especially at the higher secondary level were scarce. Therefore, many students especially girls were not in a position to have secondary education. As a result, a significant number of students would drop out after completion of primary education, and the girls were the worse sufferers who had to stop their study forever and embrace the fate of early marriage. Under these circumstances ASS took initiative to established a school in the same village.

Apart of this initiative ASS shared with village elite and social worker and taking cooperation specially financial support and established "Jangua Noakandi Adorsha Biddaloy". In 2017. The school's expenditure is being bearded by joint venture with local community.

At present 250 students in them male 130 and female 120 are studying in this school. The teacher number is 10 where male 5 and female 7.

Goal

Quality of education and learners' entrance to primary and secondary education will be enhanced in Narayanpur Union under Belabo Upazila of Narsingdi district.

Objectives

- To ensure enrollment of the learners especially of the girls in primary and secondary high school.
- To reduce dropout rate of the children completing primary education.
- To raise capacity of the educational institution in regard to ensuring quality education and fund mobilization.

5. Improving public health through awareness raising to target people

Agragati Seba Songstha (ASS) target people are poorest of the poor and poor people. Most of them are illiterate. They have lack of knowledge and different information which are very necessary for life and livelihood. Specially have inadequate knowledge on primary health. As a result target people are suffering different diseases like dysentery, diarrhea, bally pain, skin diseases and so on. They are also suffering from malnutrition.

Other hand most of them don't information where they will have services.

To address aforesaid problems, ASS implementing following activities for their beneficiaries;

- ✓ Arrange group meeting at samity level
- ✓ Sharing with small groups (5-7 persons)
- ✓ Link beneficiaries to different government service providing institute/centers
- ✓ Refer beneficiaries to different non-government health service providers
- ✓ Assist to beneficiaries to go hospitals
- ✓ Counseling to sick/ill beneficiaries to get relief in different manner
- ✓ Observe different health affair days
- ✓ Arrange discussion meeting
- ✓ Advocacy with regarding institution/persons in favor of beneficiaries

The program is supported by own fund and Directorate of public health under ministry of Health & Family Planning, Govt. of Bangladesh.

6. Access to safe water and Sanitation

Water & Sanitation Program is one of the major development activities of ASS. Safe drinking water and hygienic sanitation is a must for the safety of life as well as sound environment. ASS undertook this program in order to ensure safe drinking water and hygienic sanitation in the rural area because the people of this area are badly informed, less aware and indifferent about the importance and need of safe drinking water and hygienic sanitation.

ASS has been implementing Water and Sanitation program under financial and technical assistance of NGO forum for Drinking Water supply and Sanitation considering the inadequate access of villagers to safe drinking water and hygienic sanitary facilities.

Agragati Seba Songsth (ASS) undertook Sanitation Program in order to ensure hygienic sanitation in the rural area because the people of this area are ignorant, unaware and indifferent about it. As a result the people of this area had to face various water borne diseases and nasty environment. NGO forum for safe drinking Water Supply and Sanitation provides financial and technical support for the program.

So far ASS has distributed 28 sanitary latrines and assists to 200 beneficiaries to get latrine from Union parishad.

7. Tree plantation for environment protection

Tree Plantation is an important activity of Agragati Seba Songstha (ASS. Through this activity it provides technical support to the beneficiaries on plantation and planting sapling and some extend provides quality fruits and timbers sapling to them for homestead plantation in the year 2009. Major activities are given below;

- Awareness raising on environment and afforestation
- Assist beneficiaries to get quality seed and sapling
- Link beneficiaries to the government and nongovernment regarding service providers
- Provide training on plantation
- Loan support to target people for plantation

ASS has distributed total 2500 fruits and timber saplings among the beneficiaries. ASS has a plan for provide technical support and training to beneficiaries on grafting and budding for improvement of local and low quality of fruits trees.

8. Empowerment of persons with disabilities through providing supports

Disability is human diversity. Lack of awareness, knowledge and sensitization on disability, most of the community people see it negatively and could not include persons with disabilities in the social development process, violating persons with disabilities rights and entitlements. As a result persons with disabilities are not being enjoying their rights and living under poverty with inhuman life. They are mostly also excluded from the family and social festivals as well as depriving from education, health, economic activities. They have very less access to existing government and non-government services. WHO finding in 2013, 15% people are suffering from different degree and level of disability in the world. This percentage is higher in dense populated country like Bangladesh. Total development is not at all possible without development of persons with disabilities.

Exclusion of persons with disabilities from social development process-- One hand Human rights is violated, other hand total development is not be achieved.

ASS believes in that disability issue is not only human rights issue but it is a development issue for Bangladesh as well as world. So ASS had taken this disability development program as a core program since 2008. The main objective of the program is to preserve rights of persons with disability and build a disability inclusive society for their better life and livelihood where they will feel also dignity as like general people.

ASS implementing this program with it own fund and collaborating with other local, national, international NGOs and other stakeholders through exchanging knowledge, skill, information, logistics and financial supports.

So far ASS provided services to near about 78 persons with disabilities

Following major activities have been implementing under the program:

- Awareness raising of community people on disability issue
- Identification of persons with disabilities
- Assessment disability of identified persons with disabilities
- Awareness rising and capacity building of persons with disabilities
- Refer to persons with Disabilities to local donor for assistive devices
- Provide referral services to persons with Disabilities in different specialized hospital/service centers
- Provide medical services to persons with disabilities
- Provide life skill training to person with disabilities/families members through other organization
- Provide loan support at less interest among the disabled people to rehabilitate them in various IGA sector
- Enroll children with disabilities into school and provide education support
- Advocacy and liaison with different government and non-government service providing institutes in favor of persons with disabilities
- Networking with other disable based organization, forum and stakeholders

9. Legal Aid support to target people

To get justice is human rights but it often violating in the working area. ASS is striving to make judge society with other stake holders. We observe many of our beneficiaries have not proper justice for their lack of knowledge on how to get justice from courts. Sometime due to scarcity of financial solvency, they don't show interest to get justice.

Ultimately they deprive from justice and hampered financial sometime dignity which turn them tolead a poor life with frustration.

To address aforesaid problems, Agragati Seba Songsth (ASS) implementing following activities;


- Arrange group discussion meeting on different laws specially family laws
- Meeting with them to raise knowledge on justice system in country
- Link the victim to district legal Aid committee to get justice
- Provide support to victim to logical justice
- Provide financial and counseling support to victims
- Advocacy with regarding institution/persons in favor of beneficiaries

10 Training & Documentation

Organization provides life skill training to beneficiaries and staffs. It has a training centre and 2 trainers. It prepares documents and collect necessary document for disseminating information & knowledge specially to staffs and beneficiaries including other likeminded organization.

Organizational Structure

A. General Committee

Agragati Seba Songstha (ASS) has a 23-member General Committee (GC) comprising local elites, social workers, professionals which also significantly represented by the women members. The General Committee is the supreme authority of the organization which executes policy formation, decision and program/project implementation. It holds the Annual General Meeting (AGM) every year and elects Executive Committee (EC) after two years for smooth running of the organization. ASS can call Emergency General Meeting (EGM) at any time, if necessary.

B. Executive Committee (EC)

The GC elects a 7-member Executive Committee (EC) and a 5-member Advisory Committee (AC) biennially through democratic election system. All these committees are significantly represented by the women members. EC meets quarterly on regular basis and can call emergency meeting with 24 hours notice, if necessary. However, the Executive Committee plays an active role in running the organization.

Executive Director (ED) is the ex-officio secretary of EC and head of the organization. He is appointed by the EC and also accountable to the EC. He executes the plans and activities of the organization with the approval of the EC. The staff members of the organization are accountable to the Executive Director.
